# **GENERAL TERMS & CONDITIONS SOFI 64**



## **ENROLLMENT**

Completed registration form and level test, together with a deposit of 300€ should be received at least 2 weeks before your course starts at SOFI 64 (13 bis, rue de bouney. 64600. Anglet, France).

For any registration, the student must pay a registration fee of 70€.

A confirmation of enrollment will be sent by email.

#### **MINOR STUDENTS**

Students from 17 years old are welcome in our adult programs. SOFI 64 do not provide any specific supervision for these students. Parents must complete our obligatory parental consent form indicating: personal details of who to contact in the event of an accident or serious problem / evening curfew times / medical authorization for all types of surgery.

## **COURSE OR ACCOMMODATION MODIFICATION FEES**

Students who modify their course, accommodation or dates less than 2 weeks prior to arrival at SOFI 64, or during their stay, will be liable to a supplementary 25€ administration fee.

#### **VISA**

Students residing outside of the EU planning on staying for more than three months must apply for a 'long stay' visa from their local French Consular Service in their country of residence. Upon receipt of the enrollment form and the required deposit, SOFI 64 will issue a letter of acceptance together with proof of accommodation as required to obtain a visa. (In some cases full payment of course and accommodation may be required).

In the event of an unsuccessful visa application, supported by written proof from the French Embassy, SOFI 64 will refund the total amount paid.

# **PAYMENT**

Balance of payment must be made on the first day of the course. Payments are to be made in Euros by:

## **CANCELLATION**
